

Royal Parks Half Marathon – Terms and Conditions for Participants

Thank you for registering to participate in the Royal Parks Half Marathon to raise money for Look Ahead.

To take part you must agree with the terms and conditions below. We suggest that you keep a copy of these terms and conditions for your records.

Fundraising:

- You agree to pay a registration fee of £35. The registration fee is non-refundable; it does not contribute to your final fundraising target and cannot be rolled over to any future events.
- You agree to commit to raising the minimum fundraising target of £350 (excluding Gift Aid) in sponsorship to Look Ahead. Sponsorship in donations is non-refundable.
- You agree to act lawfully when fundraising in aid of Look Ahead and comply with any instructions or guidance provided in relation to your fundraising activities.
- If you are organising additional events or fundraising activities to support your fundraising efforts, then you agree that it is your responsibility to organise all aspects of any fundraising activity undertaken by you. You will also be responsible for any costs, taxes, insurances or expenses incurred or arising in connection with your fundraising activities.
- You understand that if Look Ahead feel you are not committed to reaching your fundraising pledge, you are at risk of losing your charity place and that Look Ahead reserves the right to withdraw your charity place in these instances.
- You agree to pay over to Look Ahead all sponsorship money within 6 weeks after the event date.
- When producing any materials using The Look Ahead logo, you must first seek approval from Look Ahead Care Communications Team.

Your Event Participation:

- You agree to notify Look Ahead as soon as possible if you are unable to take part.
- Your place in the event is personal to you and you may not transfer it or any of your other rights or obligations to any other person without our prior written consent and provided that the Event Organiser consents to such transfer. We may refuse to consent to such a transfer where it is reasonable for us to do so.
- It is your responsibility to check that you are above the minimum age to participate in the event, as specified by the event organiser, and to organise parental consent if required.

- You agree that you are entering the event of your own volition and therefore confirm that your general state of health and fitness is good and that you understand that any injury or loss sustained by you during the race/training is your own responsibility and not the responsibility of Look Ahead.
- If you have a medical condition or are unsure of your physical ability to take part in the event, you must seek medical advice from a general practitioner prior to participating in the event.
- You take responsibility for registering to take part in the event on the online registration console (if required). Failure to do so will mean you cannot take part in the event.
- You understand that it is your responsibility to read any terms and conditions issued by the event organisers and to comply with these.

Consent and photos

- By providing your personal information when you sign up to fundraise for Look Ahead, you understand that Look will contact you via phone, email and any other legitimate means in order to communicate relevant event information throughout, in the lead up to and following your participation in this event.
- You acknowledge that Look Ahead will share your contact details with the event organiser in which you are taking part.
- By taking part, all participants confirm that they are happy for any footage or photographs taken during their participation in the event to be used to publicise Look Ahead generally, including but not limited to: website, emails, social media and video broadcasts.
